# Executive Summary

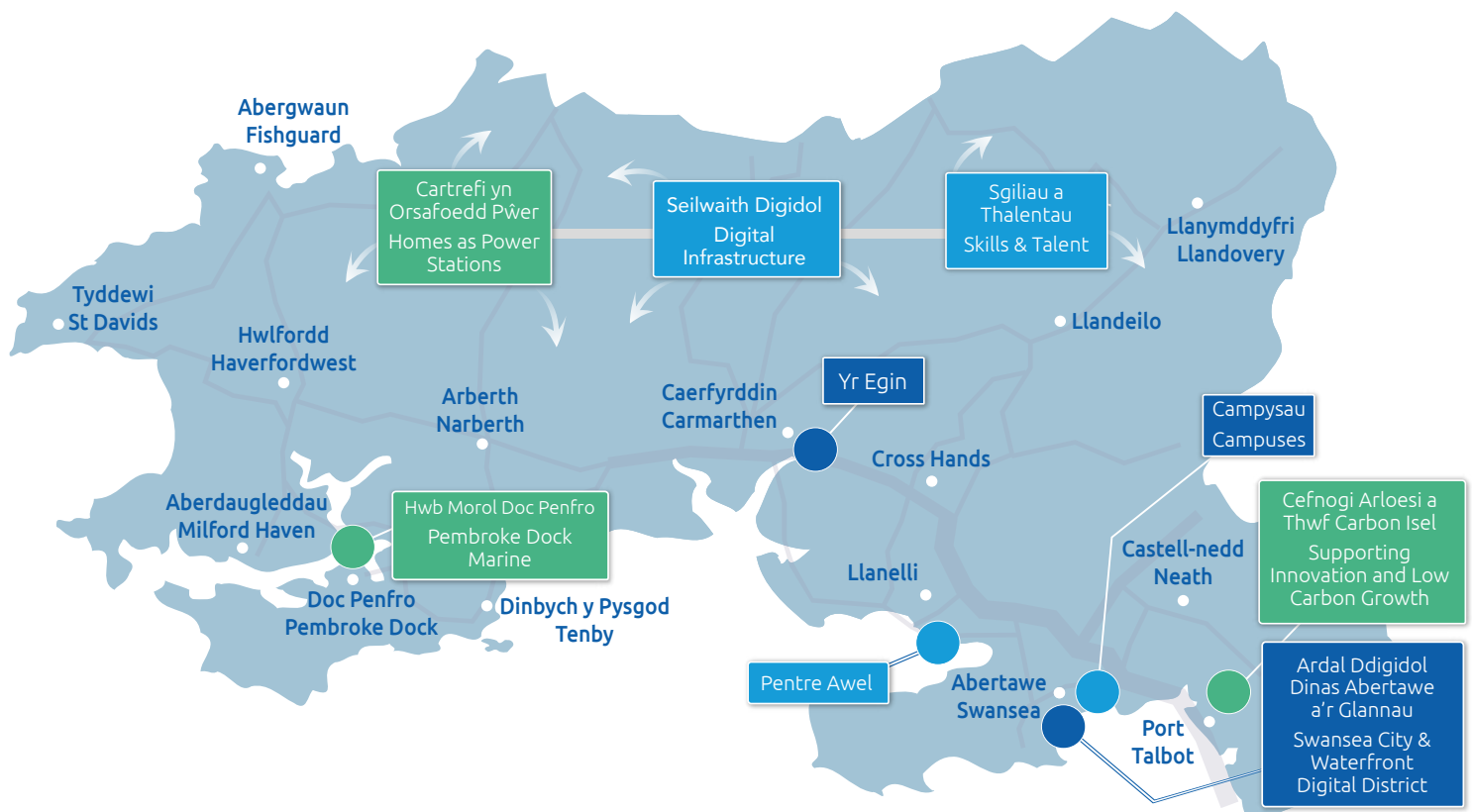
Welcome to the 2024/25 Swansea Bay City Deal (SBCD) Annual Report. As we reach the mid-point of the City Deal, exciting progress is becoming more visible across our region. In particular, the last 12 months has seen significant infrastructure being procured, built and moving into operation. Housing tenants, facilitating collaboration, and helping businesses establish and grow the City Deal is helping to transform South West Wales into a place of opportunity, where people can live and work, and businesses thrive through the creation of well-paid jobs, new skills and a first-class business environment.

The City Deal provides South West Wales a unique opportunity through a £1.3 billion Portfolio investment across nine headline projects and programmes, in the counties of Carmarthenshire, Neath Port Talbot, Pembrokeshire and Swansea.

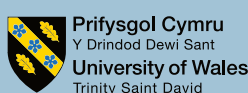
The ambition of the SBCD is to deliver key benefits to the region over a 15-year period including:

# Benefits

The City Deal has made significant progress during 2024/25 towards its benefit targets as its projects excel in delivery. These targets will continue to accelerate over the remaining lifetime of the Portfolio. Some headline achievements to date include:

- £ **£536m** of total investment.
- £ **£354m** investment in 2024/25.
- £ **£132.78m** of private sector investment contribution secured.
- At least **890+** Full Time Equivalent (FTE) jobs created\*
- 230 FTE** apprenticeship opportunities created or continued.
- 79,500m<sup>2</sup>** of completed floor space.
- 35,246** additional skills and **119** new course frameworks delivered through the Skills and Talent programme.
- £ **£44.34m** private sector funding leveraged through the Digital Infrastructure programme reported in 2024/25.
- £ **1,078** of the **10,300** Homes As Power Stations homes have been delivered leveraging **£83.6m** of investment. In addition, a further **£17.4m** of investment has been leveraged in the delivery of the project.
- 250+** contracts awarded to Welsh based companies worth over **£113m**.
- £ **6** projects completed, in operation and monitoring with a value of **£210m**.
- £ **19** projects in build or delivery with a value of **£761m**.
- £ **14** projects in pre-delivery with a value of **£403m**.

\*Further jobs have been created, and will be confirmed with a 12-24 months' time lag post completion.





2024/25 has marked a pivotal year for the Swansea Bay City Deal. As we move into the second half of Portfolio delivery, we're seeing the vision become reality — not just in physical infrastructure, but in the transformative effect it's having on our communities, our economy, and our future. # Key milestones and achievements

- **The Connected Places workstream** drives investment across the region's economic growth zones and will connect several key strategic sites, supporting our regional public sector partners' digital transformation agendas and driving additional inward investment across the region. Progress included:
  - ♦ Upgrading 69 public sector sites from copper to full fibre networks – delivered by BT through the Public Sector Broadband Aggregation (PSBA).
    - 54 sites completed and fully migrated, actively benefitting from improved connectivity.
    - 5 sites complete, pending final migration.
    - 10 sites build in progress.
    - £1,050,000 Local Broadband Fund (LBF) funding utilised in full for works undertaken to 31st March 2025.
  - ♦ Dark Fibre East - Building a dedicated dark fibre network across Llanelli, Neath Port Talbot and Swansea to accommodate the growing digital needs of partners – delivered by Virgin Media O2.
    - 19 connections completed and handed over to partners.
    - 22 connections completed all design, and survey works and are in various stages of build.
    - 4 additional connections is at the design stage.
    - UWTSO's ring across 8 University sites in Swansea City centre fully connected.
  - ♦ Dark Fibre Carmarthenshire - Competitive procurement exercise undertaken during 2024/25 with successful supplier due to be announced in early 25/26.

- **The Rural workstream** addresses the widely recognised challenge of bridging connectivity gaps, particularly in rural areas where the costs of building gigabit-capable networks can be prohibitive.
  - ♦ Better Broadband Infill Project – The project's core objective is to address gaps in connectivity across the Swansea Bay City Region. Providing gigabit-capable broadband to premises receiving speeds below 30 Mbps which are not included in commercial or publicly funded rollout plans. The team carried out detailed data analysis, cross-referencing multiple datasets to define the intervention area. Competitive procurement exercise concluded end of March 2025, a preferred supplier was identified, and the contract is expected to be awarded in April 2025.



- **The Next Generation Wireless workstream**

facilitates the rollout of 4G and 5G across the region.

- ♦ 4G/5G Public sector assets project – Making public sector assets available to accommodate digital infrastructure such as small cells to address capacity on the networks.
  - Swansea Council signed a non-exclusive access agreement with Freshwave allowing them to use council-owned assets for hosting small cells. These are small, low-power devices that improve mobile coverage in busy areas, reducing congestion and providing better signal.
  - In partnership with Freshwave, Virgin Media O2 selected Swansea as one of the locations for their next phase of outdoor small cell deployment. The installation of the small cells was completed in February 2025, with all eight units continuing to improve mobile coverage in Swansea city centre during busy times.
- ♦ Digital Innovation Network – Deployment of Long-Range Wide Area Network (LoRaWAN) gateways to facilitate the use of IoT across local authority partners.
  - Regional public sector partners have completed the rollout of LoRaWAN gateways to support IoT applications and are utilising the network to trial several pilot projects to drive operational efficiencies and cost savings.
  - Swansea Council have successfully trialled a SMART Bins Project, using LoRaWAN sensors to capture data and measure the capacity levels of waste bins across the city, enabling the waste team to respond proactively with their route planning.
  - Carmarthenshire County Council in partnership with Dyfed Powys Police are using sensor technology to tackle anti-social behaviour. This is providing useful data to inform where local police officers need to focus their efforts.
  - Neath Port Talbot Council have used sensors in their car parks to identify trends and gain insights on how their main car parks are being used. Helping to drive decisions around car park management and investment.
  - Pembrokeshire County Council are using sensor technology across several use cases everything from bee hives to environmental management in Council buildings.



- ♦ 5G Innovation Fund – A grant fund to support with capital costs associated with deploying 5G infrastructure and advanced wireless technology for specific use cases aligned to the strategic goals of the Swansea Bay City Deal.
  - Swansea University signed a contract with Vodafone to deliver the infrastructure that will underpin the Campuses 5G Project which was awarded to the university in November 2023. Planning has been approved for the infrastructure builds in Swansea and three PhDs have been awarded which will utilise the new infrastructure to conduct research and trial innovative solutions in health and wellbeing.
  - Pentre Awel are in discussions with their tenants to understand the opportunities associated with 5G/advance wireless technology that could be realised at this world class health and medical research facility.
- Ospreys' rugby hosted a workshop in early 2025 showcasing their plans for a stadium of the future with key stakeholders, which includes creating a private standalone 5G network to enhance the fan experience, provide high quality broadcasting and management of stadium operations. Bid expected in Quarter 1 2025/26.
- The region's Digital Champions were shortlisted for the Barrier Removal Award at Connected Britain 2024 which is a great recognition to the barrier busting work carried out by both the regional and local authority teams.
- Held first annual Digital Innovations and 5G Technology event highlighting how this technology can shape the future.
- A series of video case studies have been developed along with educational animations that address common questions from businesses and residents.

## Key milestones for 2025-26

- Complete upgrading of 69 public sector sites across the region from copper to full fiber networks.
- 45 connections at 37 public sector sites.
- Release 5G Innovation Funding to Campuses project on completion of infrastructure build and monitor delivery of use cases and outputs.
- Commence build of Dark Fibre Carmarthenshire Network.
- Host the annual event - Navigating the Path to Better Connectivity. It will provide an overview of the current landscape, ongoing initiatives, and the critical issues surrounding digital connectivity.
- Complete contract award for Better Broadband Infill Project. The project will deliver full-fibre broadband to more than 1,500 premises across six tranches.
  - ♦ Complete planning and surveying tranches 1- 3.
  - ♦ Tranche 1 – 220 premises connected by end of Q3 2025/26.
  - ♦ Tranche 2 - 220 premises connected by end of Q4 2025/26.
- Continue to work with both UK and Welsh Government on supporting future interventions including Project Gigabit and Extending High Speed Broadband project.

# IN FOCUS...

## Working together to get better broadband

Dale, a small rural community on the coast of Pembrokeshire, has long endured poor internet connectivity that has plagued its residents with little to no ability to use the internet for work, entertainment or communication. As more services and day-to-day tasks are digitised, having limited internet access was having a detrimental effect on residents.

However, after being told about a UK Government funded project by Pembrokeshire County Council's Digital Champions, this has changed and much of Dale is now connected to gigabit-capable broadband that serves the whole village.

The Gigabit Broadband Voucher Scheme is part of the UK Government's Project Gigabit programme, focused on helping hard-to-reach communities upgrade their broadband connection. Eligible homes and businesses can apply for up to £4,500 to cover the costs of a gigabit-capable connection. With the voucher scheme, residents and businesses in eligible areas have been able to apply for financial help to cover the costs of installing gigabit broadband.



The difficulty for me working in a technological environment, broadband connection was pretty limited when I moved back to Dale – moving large files, not being able to make video conference calls, we were stuck with old fashioned copper telephone lines. The Gigabit broadband scheme was like a lifebuoy thrown to us as we were drowning in the slow lane of the internet.

The scheme has meant our lives are enhanced and it's a benefit to our community.

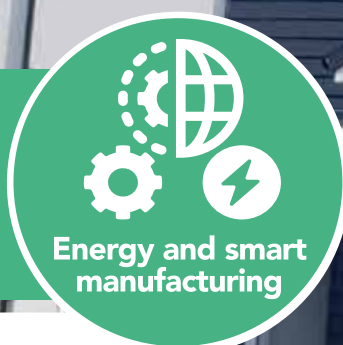

# Key milestones and achievements

- Installation of HAPS technologies into the demo houses in Margam, NPT, was completed and open days held to showcase the houses. These were developed in conjunction with Tai Tarian and Cardiff University's Welsh School of Architecture, funded through £250k of UK Governments Shared Prosperity Funding by NPT Council. [Read more.](#)
- Two further applications agreed in principle to receive Financial Incentives Funds (FIF) which means 19 applications have now been approved since the funding opened. This utilises £4.3m of City Deal funding and leverages an additional £49.5m of public and private sector funding.
- Successful allocation of £200k Skills and Talent programme funding for the Renewable Horizons pilot project. Rewise, a training provider. They will be attending schools across the region to deliver renewable energy workshops, working alongside HAPS to highlight local development.
- Outputs and levels of monitoring required for retrofit houses was designed and devices installation commenced.
- Worked with the Development Bank of Wales to share information and ensure all housing developments across the region are maximising the opportunity for creating HAPS homes.
- Ongoing Technical Monitoring and Evaluation planning meetings with Cardiff University Welsh School of Architecture to ensure collaboration with existing work and current opportunities.
- Recruitment of Joel Stenlake as the HAPS Technical Co-Ordinator.
- Events:
  - ♦ Led on the Supporting Businesses in Neath Port Talbot / Meet the City Deal Event held in Margam Park which welcomed over 75 attendees.
  - ♦ Co-ordinated the Daikin Stakeholder Engagement event in the Botanical Gardens, Carmarthenshire to showcase the opportunities of head pump technologies.
  - ♦ Presented at the South West RLSP Retrofit Conference in Parc y Scarlets, Carmarthenshire which outlined industry requirements and areas of development.
  - ♦ Attended Welsh Governments Net Zero Carbon HWB Skills and Training Group.

## Key milestones for 2025-26

- Launch the £7m Supply Chain Development Fund which will leverage the regional demand to attract manufacturers, suppliers and installers to the region and to stimulate existing companies to manufacture, train and invest in response to the region's needs.
- HAPS Event to showcase the housing schemes that are benefiting from the FIF.
- Allocating the remaining FIF, aligned to each of the Local Authority's needs.
- Continue to seek opportunities to leverage additional funding that support the project objectives.



# IN FOCUS...

## Demonstrating HAPS technology in homes

In March 2024, HAPS hosted a series of open house events to successfully showcase the HAPS Demo Houses in NPT. Funded through UK Shared Prosperity Funds and working with Tai Tarian and Cardiff University's Welsh School of Architecture, two 1950's houses were retrofitted with HAPS technologies including a heat pump, battery and solar panels.

Created to support the objectives of the HAPS project, the purpose was to showcase the range of retrofit solutions available, helping to create a healthy and affordable home and create 'landlords of the future'. The demo houses also educated a wide range of stakeholders of the installation process, lessons learned and benefits.

In addition to the two retrofitted houses, the funding extended to fitting an additional 41 Tai Tarian homes with iOpt systems, non-invasive remote property monitoring sensors for Social Housing Providers that can measure electricity usage as well as humidity levels. This enables Tai Tarian to become 'landlords of the future' where they receive data directly to manage the properties and support the tenants.

The success of the project included:

- Over 370 people visited the houses through 24 events including local residents, installers, government and public sector officials and representatives from 38 different companies across the UK.
- 13 low or zero carbon energy infrastructure installed, over double the set target.
- Supported 43 houses, with an expected target of 4.



We were delighted to have had the opportunity to partner with HAPS and Cardiff University's Welsh School of Architecture to showcase the delivery of a cleaner, greener, more energy-efficient home. Having the opportunity to welcome visitors to the property, including tenants, staff, educators, contractors, and representatives from government, added real value. It allowed everyone to see firsthand the how green energy solutions coupled with energy improvement measures are possible as part of a retrofit project, whilst sharing ideas and building strong local connections that will support the future delivery of successful retrofit projects. We look forward to learning from this experience and using it to help us plan the effective retrofit of more of our homes.

# Key milestones and achievements

- 6 further skills pilot projects approved by the Regional Learning and Skills Partnership (RLSP) board, taking the total number of approved pilots to 27 and 6 apprenticeship/skills developments since the programme began. [Read more.](#)
- 6 pilot projects have been completed with all of them exceeding the original targets.
- Skills Barometer reviewed and updated with training provision migrated onto a digital system.
- Further development of website [www.rlp.org.uk](http://www.rlp.org.uk) – with information about the RLSP and SBCD Skills and Talent programme, latest news section, and a summary of approved pilot projects.
- Additional marketing material produced and circulated to students, parents and businesses showing career pathways roadmaps available in colleges and universities across the region.
- Work Experience pilot rolled out at Ysgol Dyffryn Aman school, which includes real life industry experience alongside classroom project work. A scoping exercise is being carried out for roll out to other Local Authorities.
- Dean Ward, Founder and CEO of DCW Group appointed as the new chair of the RLSP.
- Teacher Encounters pilot complete and evaluation report prepared for Welsh Government. This was to support teaching staff at Dwr Y Felin Secondary School in Neath with the implementation of the new curriculum for Wales, allowing them to transfer their subjects into relevant industry requirements.
- Attendance at Parent Evenings in two schools per local authority to raise awareness of the SBCD, the Skill and Talent programme and upcoming local career options. Engagement with parents and teachers was very well received and has provided further opportunities to work collaboratively.
- Work Experience pilot planned for Ysgol Dyffryn Aman school which will include real life industry experience and classroom project work. This will be rolled out in the next academic year.
- Workshop held with pilot project leads and City Deal project managers to share best practice and what activities have been undertaken. The workshop was successful and is planned to be repeated.



## Key milestones for 2025-26

- First cohort of user centred design apprentices due to complete. This is the first in the UK in development and delivery, meaning that South West Wales is leading the way in meeting global digital skills gaps.
- Launch of flagship Regional Skills Intervention built to meet employer skills needs in real time, reacting immediately to sector demands.
- 8 companies from the region have been approved for the Fit For Offshore Programme funded through the Skills and Talent programme, which will enhance opportunities for companies to compete in the offshore marketplace.
- Further workshop to be held with pilot project leads and SBCD PMs to share best practice and what activities have been undertaken, encouraging further collaboration.
- Further pilot projects moving to completion.
- Identify skills gaps that remain in the region.

# IN FOCUS...

## Success of Low Carbon Net Zero Awareness Raising Pilot

Cyfle, a leader in providing building skills and apprenticeships, has successfully completed its pilot project, collaborating with regional schools and colleges to raise awareness of net zero and low carbon technologies within the construction sector. Closely linked with several City Deal projects its aim was to address the urgent need for carbon reduction in the construction industry by delivering industry-relevant carbon reduction training.

By the end of the project, Cyfle had equipped individuals with the skills necessary to meet the growing demand for expertise in this area and superseded its targets. Key achievements included:



**1,124** individuals gained additional skills



**157** people were helped into apprenticeships



**30** pupils engaged with additional skills



**164** individuals supported by jobs

## Developing a Welsh Medium learning pathway in Engineering and IT

Specifically addressing a skill gap, this project involves two Welsh Medium schools (Ysgol Gyfun Bro Myrddin and Ysgol Gyfun Maes Y Gwendraeth) along with University of Wales Trinity St David working together for the opportunity to achieve level 2 and 3 qualifications in Engineering and Digital Studies in Welsh. By working with the University, the students will gain a greater awareness of the sectors opportunities and help develop more practical skills using the equipment and research creating a seamless transition to higher education.

This is an extension of a tested project approved in 2019 which offered the first opportunity in Wales for young people in two schools in Carmarthenshire to study Engineering and Digital studies through the medium of Welsh at a Level 2 and Level 3. The schools skilled over 800 pupils between 2019 and 2023.



The Skills and Talent programme have been a catalyst for transformative change, enabling our innovative educational initiative to reach new heights within our schools. This funding has not only expanded access to vital learning resources but also empowered learners with future-ready skills, fostering long-term regional growth and opportunity.

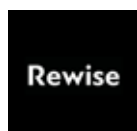

## Net Zero Wales

Developing a framework of short, micro credential courses designed to address the increasing issue of the green skills gap in manufacturing related industries both in the private and public sectors. These innovative range of courses will help build knowledge and skills as well as develop career pathways to support Wales in meeting the national net zero goal.

# Key milestones and achievements

## Pembroke Dock Infrastructure (PDI)

- Official opening ceremony to mark the completion of PDI which includes a supersized slipway and workboat pontoons, extensive laydown space and the renovation of the Sunderland Hangar Annexes into offices and work space. Deputy Prime Minister Angela Rayner, Prif Weinidog Eluned Morgan and the Secretary of State for Wales, Rt Hon Jo Stevens MP attended the opening event. [Read more.](#)
- Welcomed new customers to use the new workboat pontoons and to the Hangar Annexes.
- Hosted several investor delegation visits.
- Hosted the Global Underwater Hub (GUH) supply chain event for the Welsh subsea supply chain to engage directly with GUH and discovered how their extensive resources, networks, and industry insights can benefit subsea operations.
- Held regular commercial property open days to promote new Hangar Annex facilities.

## Pembrokeshire Demonstration Zone (PDZ)

- Celtic Sea Power (CSP), as third-party manager for the PDZ continued to build advocacy on the back of credible evidence for broadening the zones lease from a wave and tidal energy site to also include offshore wind and hydrogen technologies.
- Its proximity to Celtic Sea lease areas, the industrial capability and capacity including Pembroke and Port Talbot make it a strong candidate to deliver commercial scale test site for the UK, which if realised could significantly contribute to regional growth from offshore wind innovation and delivery.
- Leverage investment and collaborate to progress PDZs mission:
  - ♦ Provided £70k funding to CSP's collaborative Milford Haven: Energy Kingdom (MHEK),0 which leveraged £1.44m of funded activity from Innovate UK, Wales and West Utilities and private sector funding from Dolphyn Hydrogen. MHEK will help develop engineering design for a commercial investment into the PDZ using ERM's Dolphyn Hydrogen technology. ERM is the world's largest specialist in sustainability consultancy.
  - ♦ CSP were the architects of the Subsea Soundscape Project and supported Offshore Renewable Energy Catapult (OREC) to secure funding from the Offshore Wind Growth Partnership. £150k of funding has leverages a further £350k from the fund and will provide baseline environmental data for the PDZ and wider Celtic Sea.





## Marine Energy Test Area (META)

- Tests concluded at various META sites including:
  - ♦ Dale Road and East Pickard Bay: PEBL (Welsh a Welsh environmental monitoring organisation) deployed novel remote environmental monitoring stations and successfully completed the trials of remote monitoring stations.
  - ♦ Criterion Jetty: ERM Hydrogen Barge deployed.
- The Coasting into Marine Energy schools project was launched in the previous financial year in conjunction with the Skills and Talent programme, Lloyds Register Foundation and the Port of Milford Haven where 5 groups of learners from Pembrokeshire put forward an idea for a tests or experiment linked to Marine Energy. Groups from Gelli Aur School and Fenton County Primary School developed ideas to create microhabitats for hard structures which were presented to experts. These ideas were tested with an experiment in META, and pupils analysed their results. Saundersfoot County Primary also made models of Floating wind platforms and investigated how to improve their stability.

## Marine Energy Engineering Centre of Excellence (MEECE)

- Partnered with Celtic Sea Power and University of Exeter to deliver the Subsea Soundscape project. Funded by The Crown Estate, the project will pioneer a new regional approach to monitoring underwater sound in the Celtic Sea to support with future environmental assessments for new floating offshore wind in the region.
- £29k of funding to support delivery of the Hydrogen Port Refuelling project (HyPR 2) led by Port of Milford Haven and funded by the Welsh Government HyBRID SBRI 2.0 Phase 2 programme.
- £23k of funding from Agile Cymru to encourage cooperation across the Irish sea on offshore wind decommissioning and circular economy.
- Attended, exhibited and delivered a supply chain panel session in conjunction with High Value Manufacturing Catapult at Future Energy Wales conference.
- Exhibited in a 2-day Spotlight event in London, attended a Celtic Sea All-Party Parliamentary Group meeting in Westminster and supported the Port of Milford Haven with a presentation to Japan Marine United.
- Won £328k Innovate UK funding under bilateral UK-Singapore programme to deliver the AMBROSIA project demonstrating innovative offshore environmental monitoring technology.



## Key milestones for 2025-26

- **PDI:** Continue commercial operations in the workboat pontoons, Hangar Annexes, slipway, and laydown space. Port of Milford Haven will evaluate the business case for lot 3 works.
- **PDZ:** Celtic Sea Power to secure lease variation from The Crown Estate.
- **META:** Established as a marine energy test facility, it will conclude its SBCD funding in June 2025. It will strive forward as a fully operational facility attracting next generation devices to Wales for testing and validation.
- **MEECE:** ORE Catapult will deliver an Environmental Monitoring Innovation Competition, supporting three new technologies to be demonstrated in META. Aim to generate £200k revenue from external funders.

## IN FOCUS...

### Official opening of Pembroke Dock Infrastructure

In August 2024, PDM achieved a significant milestone with the official opening of the Pembroke Dock Infrastructure (PDI) element of the project. Held in Pembroke Port, the event celebrated the launch of a new, multipurpose green energy and engineering hub for Wales with a focus on innovation and operational efficiency. Guests included Deputy Prime Minister Angela Rayner, Prif Weinidog Eluned Morgan and the Secretary of State for Wales, Rt Hon Jo Stevens MP.

Led by the Port of Milford Haven, this development has delivered new, world-leading port infrastructure in Pembroke Dock which included a supersize slipway and workboat pontoons, extensive laydown space and the renovation of the Sunderland Hangar Annexes into flexible workspace for companies in the green energy sector.

Working collaboratively with META and MEECE and exploring the advances in the potential of the PDZ, the completion of PDI marks a huge step forward in driving innovation and creating new opportunities for industrial growth in the energy and engineering sector. In addition to the successful Celtic Freeport bid the region is starting to attract the attention from global renewable energy investors and developers.



Pembrokeshire's long heritage of maritime excellence is leading the way for the future of the UK with the launch of this Pembroke Dock Marine programme. This is a major step towards us becoming a world leader in zero-carbon marine engineering and tackling climate change for a cleaner, greener, more ambitious future for us all.

And a future where we see our bold ambitions on growth and jobs for and with every part of the UK go hand in hand with our ambitions on Net Zero and sustainable energy.

# Key milestones and achievements

- Zone 1 officially named as Canolfan.
- Canolfan construction work progressed which included the completion of the external envelope and transition to internal mechanical and electrical services, ceilings, floors, partitioning and fit-out activities. Internal works are now well advanced and centred on final finishes, decorations, fixtures and fixings. [View 360° aerial progress footage.](#)
- March 31st 2025 marked week 113 of construction works onsite.
- Hywel Dda University Health Board signed an Agreement to Lease for its health and research space at Canolfan.
- Footpath to the north of the lake completed which created a 1.38km of walk/cycle path around the lake.
- Arup commissioned as the landscape architect to undertake RIBA Stage 1 design development of the green space to the north of the site and work completed.
- Contracts awarded to Nest EV and Sustainable Energy Group for EV charging operator and Chase Services Group for site security.
- BREEAM design stage certificate issued with a score of 75.7% achieving BREEAM “excellent”.
- Bouygues UK has:
  - ♦ Exceeded its contractual commitment of 4,680 person weeks of targeted recruitment and training. It achieved a total of 5,205 person weeks to date, inclusive of 67 apprentices, 76 new entrants; 32 trainees; 11 work experience placements and 8 graduates.
  - ♦ Interacted with 817 school pupils and delivered 213 hours of school’s engagement. A second cohort of primary and secondary school pupils are participating in a real-world learning project and have been tasked with designing Zone 2 nursing home or Zone 4 wellness hotel. The project was runner-up in November’s Welsh STEM awards.
  - ♦ Four Community Newsletters issued, and four Resident Surgeries held. Community and Public Engagement events also held in Morfa, Antioch and Selwyn Samuel centres in Llanelli.
  - ♦ 75% (£54m) of Zone 1 construction spend has been retained in Wales with the use of Welsh subcontractors and suppliers, maximising the value of the Welsh pound.
- Zone 2 design brief prepared for the nursing/residential home and extra care unit which will provide a clear masterplan, programme, cost plan and concept design for the zone.
- Competitive dialogue in progress to identify a preferred development partner/operator for the Wellness Hotel in Zone 4.



# Key milestones for 2025-26

- Opening of Zone 1 and transition of Llanelli Leisure Centre to Pentre Awel.
- Deliver programme of fit-out works to health and business spaces and secure tenants.
- Conclude competitive dialogue exercise for Wellness Hotel in Zone 4, identifying a preferred development partner/operator.
- Confirm feasibility of assisted living accommodation in Zones 2 and 3 following initial concept designs.

## IN FOCUS...

### Net Zero in Construction

Bouygues UK, the principal contractor building Pentre Awel, has worked with its sub-contractors and supply chain through the 24-month build to achieve net zero on the construction stage.

This includes:

- Over 90% reduction on direct emissions of all fuels on site
- 10% reduction in waste production and energy and water consumption.

Resulting in a saving of over 450 tonnes of carbon emissions.

The project has implemented energy, waste and resource-saving initiatives including:

- Adopting sustainability-certified hydrotreated vegetable oil (HVO) as fuel. This initiative will be rolled out to all Bouygues UK sites across the UK.
- Sourcing recycled and green materials.

24 specific initiatives were targeted to help reduce emissions, waste and energy which included:

- Solar-powered site office and CCTV cameras.
- Source recycled building materials including reinforced bars with 98% recycled content and structural steel with 80% recycled content.
- Soil from the surface during excavating taken to a local recycling facility to be segregated, treated and reused.
- Partnership with Gaia to identify, monitor and reduce power consumption using AI and sensors. Energy savings using Gaia is 47.9%
- A carbon consultant to identify low carbon solutions, monitor waste, carbon and deliveries and upskilling the workforce on climate and environmental topics.



We are immensely proud of this achievement. As well as building a state of the art, top quality facility, as a project team we set our minds to reducing as much of our carbon emissions as possible. We set out a plan and I'm so pleased to say that we have achieved it.

## Property Development Fund (PDF)

- Round one - The three projects that were shortlisted commenced on-site work.
- Round two - Three projects are currently going through the application process.
- The PDF is currently oversubscribed. In 2024-25 PDF projects secured £1,037,789.00 of private investment and is projected to exceed its £5.5m target by the end of the project.

## Hydrogen Stimulus Project (HSP)

- Hydrogen Stimulus project investment with Protium at the University of South Wales Hydrogen Centre.
- Private and public sector hydrogen project developments underway at the University of South Wales (USW) Hydrogen Centre site at Baglan Energy Park, which have led to further opportunities to optimise the hydrogen refuelling station configuration on site.

- USW are finalising the engineering approach and will be inviting tenders for installation of the additional electrolyser.

### Corryn Biotechnologies take up space at the Bay Technology Centre

In June 2024, Corryn Biotechnologies Ltd, a medical technology company that was founded to help with complex wounds moved into the Bay Technology Centre. Corryn have created a medical device which applies a polymer dressing to a wound, and the dressing gets absorbed, so does not require removal. They already have a client base in the UK and Europe.

Corryn, a spin-in at Swansea University, quickly outgrew their space in the University due to rapid growth. They approached Neath Port Talbot Council to find them suitable space in the county

and the award-winning Bay Technology Centre was selected as the ideal facility due to its convenient location and flexible space.

They initially set up a manufacturing laboratory consisting of one office and one lab but quickly grew to include an additional laboratory as well as a state-of-the-art clean room manufacturing facility. They now occupy 141sq meters at the Bay Technology Centre. The expansion is also supported by the UK Shared Prosperity Fund.



The Bay Technology Centre has been instrumental in Corryn Biotechnologies' growth and development, providing a fantastic space and support to develop our world-first medical technology right here in South Wales.

## Swansea Waterfront - Official opening of the Innovation Matrix

In March 2025, the University of Wales Trinity Saint David (UWTSD) officially opened the Innovation Matrix through a celebration event which marked the completion of the cutting edge 2,200 sq.m facility in Swansea's SA1 Waterfront. The event was attended by representatives of the Welsh and UK governments, civic leaders, and industry partners, including Rebecca Evans, MS, Cabinet Secretary for Economy, Energy and Planning, Welsh Government, Dame Nia Griffiths, DBE, MP, Parliamentary Under-Secretary of State, Wales Office, UK Government and Councillor Rob Stewart, Swansea Council Leader.

The building was developed by Kier Construction who secured £6 million worth of contracts for Wales-based businesses during the construction process.

Designed to drive digital innovation, entrepreneurship, and industry collaboration, the Matrix is situated alongside the university's existing IQ and Y Fforwm buildings. It has already attracted nine businesses to its high-quality working spaces, creating a dynamic cluster with the added benefit of direct access to UWTSD's expertise and research.



We want Wales to be at the forefront of innovating new technologies that drive meaningful change in society and benefit people in their day-to-day lives. This exciting development will nurture a first-class ecosystem for digital innovation and enterprise that can be a catalyst for economic growth and prosperity. ## Swansea Waterfront - Official handover and first tenants announced for 71/72 Kingsway

In February 2025, Bouygues UK, the contractor building the Kingsway development officially handed the premises back to Swansea Council ahead of the fit out. A handover event was held and attended by representatives of the Welsh and UK Governments, local councillors, and developers. Guests including Rebecca Evans, MS, Cabinet Secretary for Economy, Energy and Planning, Welsh Government, and Torsten Bell, MP for Swansea West were hosted by Councillor Rob Stewart, Swansea Council Leader and Swansea Council Cabinet Members.

The first two tenants were announced during the event – International Workplace Group (IWG) Plc and TUI, accounting for over 2500 sq.m meters of the building.

IWG, a flexible workspace provider will be taking up 1850 sq.m meters at the building, and once in operation plan to rent out space to businesses.

Travel and leisure company TUI are also taking approximately 650 meters. Currently based in Alexandra House, the TUI contact centre employees will move to the new development, helping retain jobs in Swansea Centre.

The majority of the remaining space is also under offer, with advanced discussions happening with a number of tenants that will be new to Swansea.

Rural Office is an award-winning architecture, strategy and research company with 11 employees. The company developed the concept design for Yr Egin building and became a tenant in 2022, taking up one of the larger commercial units.

The office space they occupy within Yr Egin offers their staff a creative environment, which they consider to be important to the type of work they do. Remote working is not really a viable option for this creative business and therefore having a modern, professional work environment is very important to them.

Rural Office feel that being located in Yr Egin supports their staff members and being in a creative environment with likeminded companies makes a big difference in the company's ability to retain staff.

The shared location spaces, including communal meeting areas and the café, mean that businesses working in different spaces often end up having informal discussions with each other; discussions which sometimes result in mutually beneficial information, advice and contacts being exchanged that would not otherwise be shared.



There's a real creative energy within the place which really helps us and our staff to be more creative ourselves. The centre provides a collegiate environment for tenants which creates a sense of identity, so you as a tenant feel like you are part of something bigger than your own business. # Financial Update

The overall investment position of the Portfolio is estimated to be £1.374bn over its 15-year life cycle, as summarised below. Total SBCD investment from all sources was £536.68m, of which £132.86m was private sector investment at the end of the financial year 2024/25.

The economic climate during construction and operational phases continues to present Portfolio delivery challenges. Several macroeconomic factors, including availability of resources and recruitment, energy prices, construction costs, inflationary pressures, the COVID pandemic, and the war in Ukraine have resulted in delivery variance and escalating cost pressures over the last five years.

Despite these challenges, all projects and programmes are progressing through delivery and all partners are fully committed to the delivery of their SBCD initiatives.

In 2024/25 financial year, the SBCD invested £98.25m on the planning, procurement, build and operations across the majority of the nine of the Portfolio's projects and programmes. Further large investments through procurement and build will take place between 2025-29.

Close monitoring, mitigation and resolution of risks, issues and communicating delivery and financial profiles with all stakeholders is continually undertaken by the SBCD Portfolio Management Office. This helps to determine the impact that the macroeconomic climate is having on the delivery of the Portfolio.

The SBCD received a further funding award in 2024/25 from the Welsh Government and UK Government, releasing the seventh annual draw-down of City Deal funding. This has taken the total drawdown to £176.6m since Portfolio commencement. The latest City Deal funding draw-down included the accelerated UK Government grant which will now be awarded over a ten-year period, rather than the original fifteen-year period.

## Private sector investment

Leveraging private sector contributions to support programme and project delivery remains one of the SBCD's highest priorities. To date, over **£132.8m** of private sector contributions has been secured with forecasts in coming years to achieve our £600m+ Portfolio target.

## Reaching out to business

Exhibiting at events during 2024/25 has helped to promote the SBCD to more than 1,000 businesses across South Wales. The PoMO will continue to build on business engagement activities over the coming year, working with projects and programmes teams to identify new avenues of engagement.

## Business engagement workshop

One of the planned activities in the SBCD Communications, Marketing and Engagement Implementation Plan was the facilitation of a cross-portfolio business engagement workshop, to developing more effective business engagement that leads to impactful outcomes for the coming years. ## Supply chain impact

Projects and programmes have a major impact to supply chains during the construction and operational phases of the SBCD Portfolio. Much of this impact is benefiting local and regional companies directly and through supply chains across Wales. They have also helped build on existing relationships and forged new collaborations that have mutual benefit to deliver the Portfolio across South West Wales.



# Achievements to date by working with businesses

- £ 35,246** additional skills and **119** new course frameworks delivered through the Skills and Talent programme.
- £44.34m** private sector funding leveraged through the Digital Infrastructure programme reported in 2024/25.
- £ 1,078** of the **10,300** Homes as Power Stations homes have been delivered leveraging **£83.6m** of investment. This includes circa **£16.23m** private sector costs for new build homes and retrofit schemes. In addition, a further **£17.4m** of investment has been leveraged in the delivery of the project.
- 250+** contracts awarded to Welsh based companies worth over **£133m**.
- £ 6** projects completed, in operation and monitoring with a value of **£210m**.
- £ 19** projects in build or delivery with a value of **£761m**.
- £ 14** projects in pre-delivery with a value of **£403m**.

# IN FOCUS...

## Business Engagement Workshop

The successful workshop was held in June 2024 in the Beacon, Llanelli and attracted 19 participants across 6 of the SBCD projects and programmes. Chris Foxall, the Chair of the ESB guided the workshop and other board members attended and participated. Jill Davies from the Circular Economy Innovation Communities (CEIC) project, was an independent facilitator leading the activities. The workshop was split into four exercises.

The key objectives were to:

- Identify effective business engagement practices that positively impact on the SBCD Objectives.
- Create a business engagement process model.
- Scope potential for future SBCD engagement events.

In the first exercise the groups discussed what they hoped to achieve from business engagement, with the outcomes being:

- Build networks, collaborations, and relationships.
- Raise awareness/profile of projects and programmes.
- Develop supply chains.
- Achieve effective press coverage / media and social media interest.
- Promote opportunities and support.
- Create a business engagement process model.

In the second exercise participants discussed who they are trying to engage with and how? They also discussed what methods are working and which aren't working? Ideas were shared and methods were ranked to help identify areas of focus.

Exercise three was a brainstorming activity which attendees were tasked with thinking as an individual and then combining ideas to work as a team. This proved the value of group thinking, with many more ideas considered compared to individual contributions.

In the final exercise the groups worked together, discussing how business engagement could be improved. They considered more adventurous possibilities not yet being used.

Key outcomes from the workshop:

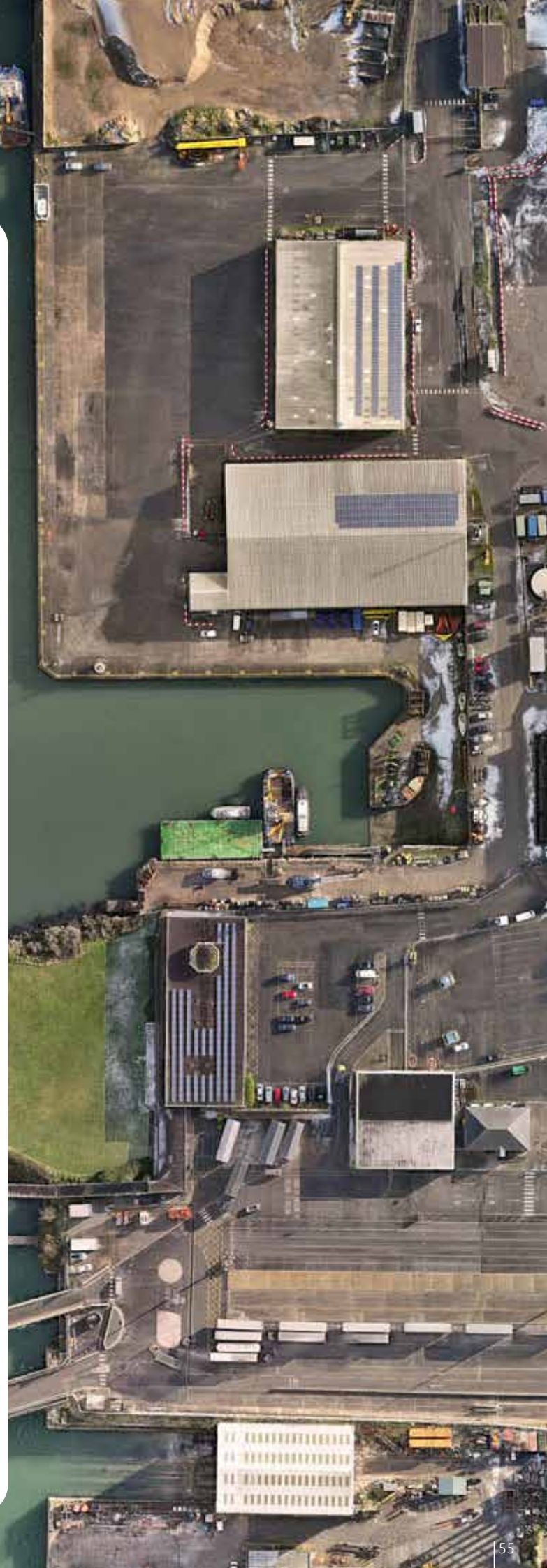
- There is no one-size-fits-all approach to engagement.

# IN FOCUS...

## Marketing and Communications Workshop

A Marketing and Communications Workshop was held in October 2024 in the Beacon, Llanelli and attracted 12 participants across 8 of the SBCD projects and programmes. Jon Burnes and Peter Austin from the City Deal PoMO facilitated the workshop, which involved three main exercises.

The key objectives were to:

- Raise importance of communicating the overarching SBCD messages.
- Understand current practice/approaches that are used and share ideas.
- Outline key milestone for the next 12 months and determine key messages arising from the milestones.
- Shape the Portfolio Communications, Marketing and Engagement Implementation Plan including the Portfolio key messages.
- Provide an opportunity for Marketing and Communications contacts to interact and build relationships with each other and develop a Community of Practice to maximise opportunities across the Portfolio.

In the first exercise the groups discussed the different stakeholders they communicated with and what methods they used. The power and influence matrix were updated and included in the Communications, Marketing and Engagement Implementation Plan.

In the second exercise, participants discussed with each other the key messages their projects and programmes would be communicating over the next 6 months.

In the final exercise, the groups looked at their own project and programme key messages and put together key messages for the SBCD Portfolio to use during the next year.

The workshop was very well received with:

- **86%** satisfied with the overall workshop.
- **86%** satisfied with the topics covered.
- **86%** satisfied with the group activities.
- **71%** wanted more events of this type.

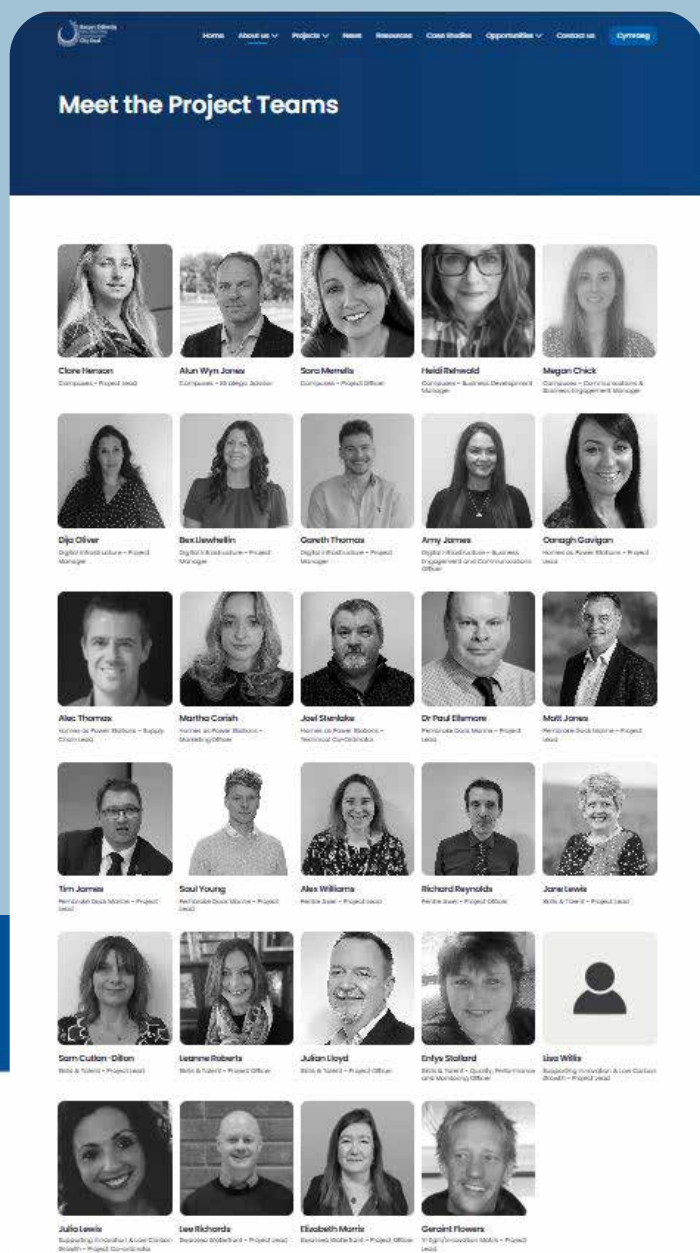
## Website Upgrade

## Animation

One of the most common questions asked at events and when networking is “how does the City Deal benefit me?”

Working with Swansea based supplier Echoworks, the PoMO produced a short animation, which explained the City Deal and how the headline £1.3bn flows into the region, and how it benefits people – residents and businesses.

# Assurance and Audit

The SBCD Portfolio, programmes and projects are subject to Office of Government Commerce Gateway Reviews, facilitated by the Welsh Government Integrated Assurance Hub. The reviews provide third party assurance of successful progression and overall delivery of the Portfolio and associated projects and programmes.

The SBCD Portfolio undertook its previous strategic review in July 2023. A Portfolio review was not scheduled for 2024/25 due to the robust nature of the SBCD governance arrangements in place. The next review is planned for July 2025.

A schedule of forthcoming reviews has been developed for the next 12 months. Regular meetings of the SBCD Assurance Panel have taken place throughout the year, providing oversight and input into the assurance arrangements across the Portfolio.

The table below shows the current assurance status across the Portfolio together with the Delivery Confidence Assessment rating (DCA) and the estimated date for the next assurance review.

## Portfolio Gateway 0 Review Recommendations

The 2023/24 Gateway assurance review for the Portfolio returned a third consecutive Amber/Green rating with 4 minor recommendations, all of which have been actioned. The recommendations covered

communications regarding strategic intent, benefits management, governance alignment with the Corporate Joint Committee (CJC) and maximising value from dependencies and opportunities, particularly in relation to the private sector.

## Audit

An internal audit was undertaken for the SBCD by Pembrokeshire County Council for 2024/25. The audit returned a Substantial (Green) rating with 2 recommendations relating to forward financial planning and Service Level Agreements.

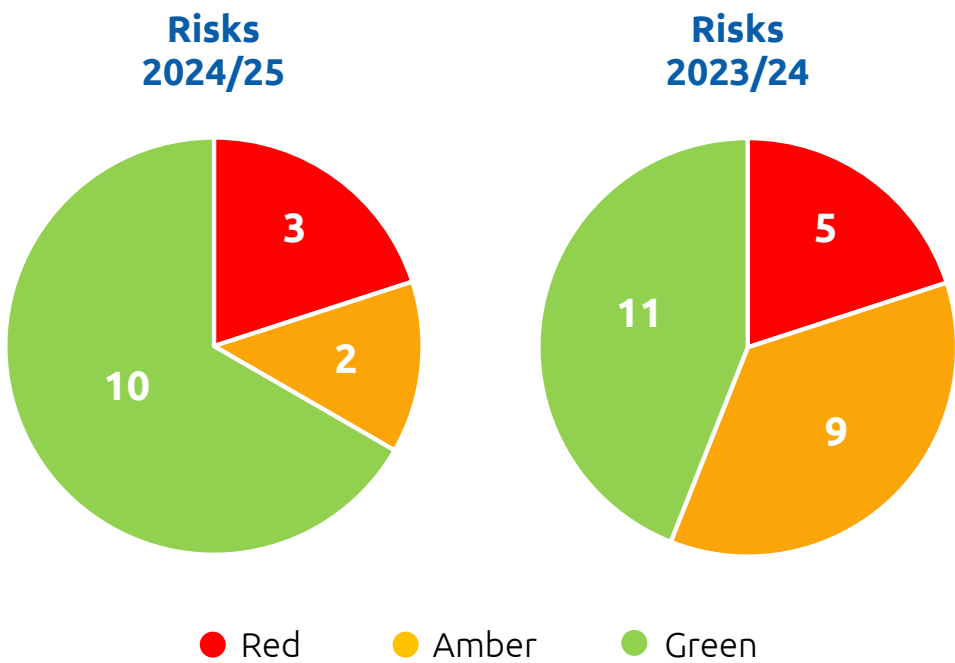
An Audit Wales Assurance and Risk Assessment review was undertaken for the 2022/23 period. The review found that the SBCD Portfolio management arrangements support clear insight into the Portfolio's progress. Sixteen areas for resolution

were identified to formally review the existing arrangements to ensure they are the right fit for future needs. An action plan was prepared to report on progress via SBCD governance, which included alignment to CJC, benefits realisation/evaluation, Portfolio management arrangements, purpose of ESB, role of regional scrutiny, lessons learned and regional opportunities. Five of the areas are complete, five are in progress, four are on-going and in progress and two are yet to be actioned. The next Audit Wales Review is scheduled for June 2025.

# Portfolio Risks and Issues

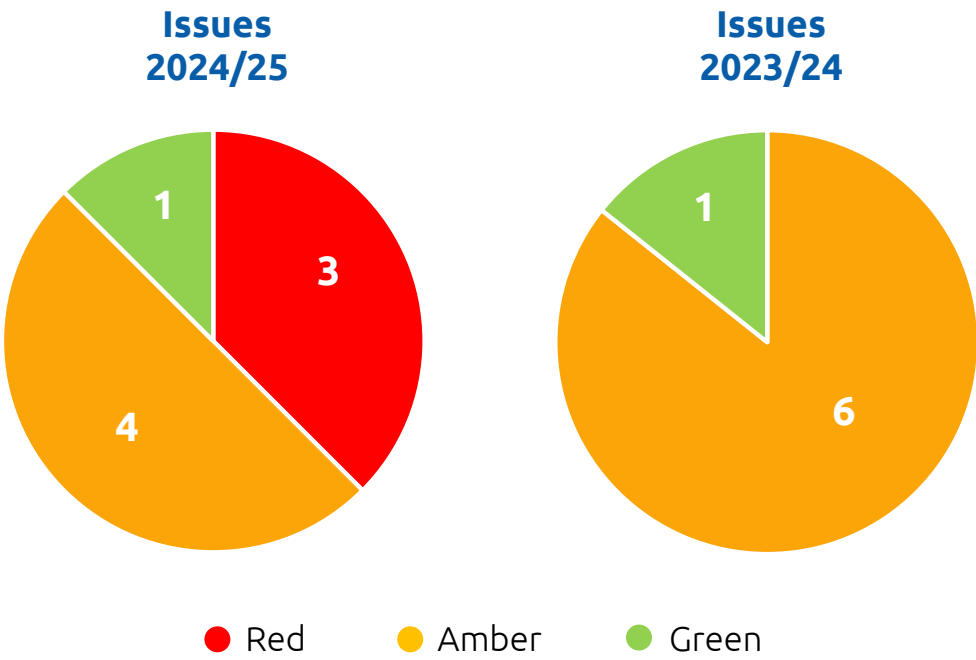
The PoMO monitors and reports Portfolio risks and issues to Governance Boards on a quarterly basis, providing updates on status and mitigations.

The number of Portfolio risks reduced from 25 to 15 within the year with no new risks identified. The number has reduced due to risks being closed or elevated to issue status.
